- 2. For best results, cut cake into required portions while frozen, using a sharp knife dipped in hot water.
- Cover and return unused frozen portions to the freezer immediately.
- 4. Thaw sliced cake portions in the refrigerator (<5°C) for approximately 30 minutes before serving.
