TO HEAT FROM FROZEN:

1. Preheat oven 180°C.
2. Remove outer packaging.
3. Place muffins on a baking tray and heat for 10 - 12 mins.

TO MICROWAVE FROM FROZEN

1. Heat each muffin on med-high for 15 sec.
